Post-Entry fee - \$14.00 per class and will be charged for all classes entered or added after 12:00pm on the Friday before the show.

Grounds Fee - \$20 per horse will be charged.

Trailer-in Fee - \$20 per horse per day will be charged for haul-ins.

Hay & Bedding - Will be charged at market price plus labor cost.
